I was grieving, worried and wasn't sure what I would do. Not only hurting from my 64 year-old husband passing away, I was concerned about the more than \$58,000 in loan balances we had together. I no longer work and knew I couldn't repay these alone. To my surprise, the kind Team Members at Pershing Branch reminded me of payment protection I had on these loans, saving me a total of \$58,417.





We took a financial hit with income loss, plus unexpected medical bills. We were drowning in debt and simply could not make ends meet each month. We turned to the Leitchfield Branch to see if we had any other options. They introduced us to our Home Equity Line of Credit, which has taken our monthly payments from \$1,341, down to \$218. The heavy feeling has been lifted!

At 18 years old, I knew what I wanted, but just wasn't sure how I was going to get there. I went to the Radcliff Branch to learn if a \$2,500 loan would be possible to pay for enrollment in a limited program and internship for IT engineers at the ARMY. They made it work! Not only can I continue my education without worrying about money, but after graduation I'm guaranteed a job at HRC!




