Supporting Our Veterans

This year marks the 100th anniversary of Fort Knox and the 68th anniversary of your Credit Union. As part of our ongoing commitment to empowering members through financial education and supporting the military community, we partnered with the Kentucky Small Business Development Center (KSBDC) to host the third annual Operation Veteran 2 Entrepreneur workshop this August.

This annual event allows participants to meet with valuable small business resource partners, gain management best practices for their businesses, and learn from successful veteran small business owners, like Will Rivera, who started Running Soles in Elizabethtown after retiring from the military with 24-years of service.

While he was preparing to transition from the Army, Rivera worked closely with the Small Business Development Center to develop a strong business plan and secured a Small Business Administration Loan from the Credit Union. As his business grew, Mr. Rivera and his wife decided to purchase a building in Elizabethtown's historic district. Again, he turned to the Credit Union for financing and was able to walk into the auction pre-approved. Today, Running Soles is part of the city's successful downtown revitalization effort and is motivating veterans and other residents to stay active.

Building a Stronger Community

The Operation Veteran 2 Entrepreneur initiative is just one example of how Fort Knox Federal helps empower members through financial education. These educational offerings allow individual members to control their financial futures. They also strengthen the communities we serve. When our ten founding members decided to start a credit union in late November of 1950, they weren't looking to make a profit. They simply wanted to make a difference in their community.

That mission of "people helping people" is built into the Credit Union's DNA and the positive impact we are making collectively has grown, just as our ten founding members and \$1,000 in assets have grown to 103,000 members with \$1.5 billion in assets. This year alone, we're on track to contribute nearly \$100,000 in aid to military families through our partnership with USA Cares and are lending to small business owners who provide services directly to Central Kentucky communities.

I am certain that our founders would be proud of the impact we're making today. Thank you for your membership with Fort Knox Federal – together we can continue making a positive difference for veterans, families and our local communities.


