



## Abound Federal Credit Union's SMS Texting Terms & Conditions

Abound Federal Credit Union (Abound) offers SMS (Short Messaging Service) alerting for many kinds of mobile and online banking activities. Members can opt in to receive SMS texts when transactions over a certain limit occur, to receive balance alerts, transfer alerts and to receive one-time passcodes. Abound will not use this SMS service to send you marketing or promotional messages.

Your use of our SMS service constitutes your agreement with the terms and conditions within this agreement which includes the following:

- You agree that your usage of our SMS service is conditioned on you providing us with your valid mobile phone number and on your agreement to receive messages from Abound Federal Credit Union through your wireless provider.
- You agree to provide a valid phone number for this service so that we may send you information about your account. Abound has the sole discretion to determine what information is made available through this service.
- You agree to indemnify, defend, and hold us harmless from and against all claims, losses, liability, costs, and expenses (including reasonable attorneys' fees) arising from your provision of a phone number that is not your own or your violation of applicable federal, state, or local law, regulation, or ordinance in providing us a phone number or using the SMS program. Your obligation under this paragraph shall survive your termination from participating in the SMS program.
- You agree that Abound may send any SMS communications, either directly, or via a thirdparty agent or authorized service provider, through your communication services provider to deliver it to you. You agree that your communication services provider is acting as your agent in this capacity.
- These SMS Terms supplement, but do not replace, your existing account agreements and other agreements with Abound.
- You agree that receipt of account information through SMS may be delayed or impacted by factors involving your communication services provider or other parties.
- You acknowledge and understand that the SMS is provided for your convenience and does not replace your monthly account statement(s), which are the official record of your accounts. This service may not be encrypted and may include personal or confidential information about you or your account, such as your account activity or status. You agree to protect your communications devices that receive information through this service and not to let any unauthorized person have access to the information we provide to you through this service. We will not be liable for losses or damages caused in whole or in part by your actions or omissions that result in any disclosure of account information to third parties.
- You acknowledge and understand that there is no separate fee for this service; however, you are responsible for all charges, including, but not limited to, fees otherwise applicable to your account(s) and fees associated with SMS messaging imposed by your communications service provider. Message frequency varies. By participating in the SMS Program, you consent to receive recurring automated text

messages. Message and data charges may apply. Questions concerning your text and data plan and applicable fees should be directed to your communications service provider.

By providing your consent, you are agreeing to the following terms and conditions:

- a) When you opt-in to SMS, you consent to receive recurring automated text messages from Abound or a service provider acting on Abound's behalf. If you provided consent by selecting the text option, the SMS messages may contain one-time passcodes and account alerts. Once you opt-in, Abound will send an SMS message to confirm that you own or are authorized to provide the telephone number that you used to opt-in. Your consent to receive SMS is not a condition to receiving any Abound product or service.
- b) You agree Abound Federal Credit Union may use an electronic record to document your consent. You also agree to notify Abound promptly if your mobile phone number changes or is no longer in your control. Abound may stop sending SMS messages to any number it reasonably believes has been disconnected or reassigned.
- c) To stop SMS messages from Abound at any time. You may text STOP, END, CANCEL, QUIT, or UNSUBSCRIBE from the phone number you no longer wish to receive alerts from. After you text any of these words to us, we will send you a single SMS message confirming you have been unsubscribed, after which you will receive no further SMS messages for the service associated with that number. Abound will also honor opt-out requests made through any other reasonable method that clearly expresses a desire to stop receiving SMS messages. If you want to receive SMS messages again, texting START will opt you back into the SMS program and we will start sending SMS messages to you again. For help, text HELP from your mobile number. We will reply with our program name, our member service phone number, and instructions for opting out.
- d) SMS is not encrypted. Do not send sensitive or nonpublic personal information to Abound in a text message. No representative of Abound will ever ask you to do this. If you receive an SMS purported to be from Abound Federal Credit Union that requests you send a text with sensitive or nonpublic personal information, please do not respond to it. Instead, contact us immediately at 1-800-285-5669.
- e) Abound makes no warranty regarding availability or reliability of SMS, and Abound shall have no liability related to any delay or failure in the delivery or receipt of text messages.
- f) Message and data rates may apply for any messages sent to you from Abound and to Abound from you. If you have any questions about your text plan or data plan you should contact your communications service provider. Carriers are not liable for delayed or undelivered messages.
- g) Abound may change these terms and conditions at any time. Any updated terms will be effective when posted on the Abound website. Abound will provide notice of changes when required by law and otherwise as it determines appropriate. You agree to review these terms periodically so you are aware of any changes.

These terms are governed by the laws of the Commonwealth of Kentucky and the federal laws applicable to federally insured credit unions, without regard to conflict of laws principles.
